CONSENT AGREEMENT**

In Consideration of being permitted to participate in any way in Waterford Community Fair I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. Acknowledge, agree, and represent that I understand the nature of such activities and that I am qualified, in good health, and in proper physical condition to participate in such activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the activity.
2. I fully understand that: (a) the activity undertaken involves risks and dangers of serious bodily injury, including permanent disability, paralysis and death; (b) these risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of the Releasees named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at the time and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the activity.

I hereby release, discharge, and covenant not to sue, its respectives, administrators, directors, agents, officers, volunteers, and employees, (the Releasees hereon) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations, and I further agree that if, despite the release and waiver of liability, assumption of risk and indemnity agreement, I or anyone on my behalf, makes a claim against the Releasees, I will defend indemnify, save and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability, damages, or cost which may incur as the result of such claim.

# Waterford Community Fair and Youth 2025 Camping Rules

1. Only board members, vendors, volunteers, and livestock exhibitors are permitted to reserve camp sites.
2. Camp sites will be assigned by the Waterford Community Fair board. Campers may camp in designated camping areas only. Anyone using more space than assigned will be asked to reduce the amount of space they are using. The fair board reserves the right to move any camper that is incorrectly parked.
3. No awnings or slide outs are allowed to extend into the next camping area. Campers parked alongside the barns must allow for barn windows and doors to be open properly.
4. No dumping of sewage or grey water onto the ground is permitted.
5. Trailers not used for camping will not be allowed in the camping area.
6. Campers will receive a camper permit upon arrival that is to be prominently displayed on the front of the camper.
7. All campers must have a weekly button or wristband.
8. You, as a camper, are liable for any damage to electrical outlets at your campsite.
9. Campers must have a working smoke alarm, carbon monoxide detector and up to date fire extinguisher to camp (no exceptions).
10. Electric hook ups are one per site. Do not overload your circuit. You cannot run crock pot, air conditioner and refrigerator at the same time, for example.
11. Electric cords must be 12 gauge or larger.
12. Due to liability and safety concerns, dogs and other pets are not allowed on the fairgrounds. This includes camping areas. The exceptions are service animals, or special circumstances approved by fair management.
13. Quiet Generators are allowed as long as they are running properly and not sending fumes into other campers.
14. Camping application and fee must be turned in by the deadline to ensure space reservation.
15. All person's camping are required to have an adult camping at the assigned site who will assume responsibility for their conduct. **The adult must spend the entire night at the site.**  
*(Regardless of Youth member's age, the adult at the site must be a parent or guardian.)*
16. No four-wheelers, golf carts or motorized vehicles are permitted on the fairgrounds other than Waterford Community Fair Board and Mill Village Fire Company parking personnel.
17. No horses or livestock animals are allowed in camping areas or on the midway at any time.

18. No alcohol is permitted on fairgrounds.
19. No open flames (campfires, fire pits, candles, etc.) allowed at campsites.
20. Camping areas must be clean at all times. Trash pick-up is the responsibility of the camper. All campers are responsible for cleaning up their sites at the end of the week.
21. Campers may set up their sites on the Thursday prior to fair. Request for earlier set up must be approved by the Waterford Fair Board member responsible for campers. Sites will be designated by the fair board and will be communicated to the camper.
22. All campers are to abide by these camping rules. Persons not following these guidelines may be asked to leave the camping area and will forfeit premiums.
23. Late entries will be assigned only if space is available.
